END USER LICENSE AGREEMENT (EULA)

Fresh Relevance maintains a EULA, which is subject to change from time to time in Fresh Relevance's sole discretion.

You agree that:

- 1. Your login details are personal to you and you will keep them confidential and not share them.
- 2. If you suspect unauthorized use of your login details, you will immediately change your password and notify your support contact.
- 3. If you suspect a personal data breach, you will immediately notify your support contact.
- 4. You will cooperate with your support contact if they are investigating any complaint, data breach, or other problem.
- 5. You will comply with the relevant data protection laws that apply to you and your data subjects such as shoppers.
- 6. If your work Is not yet covered by a Data Processing Addendum (DPA) or equivalent, you should get the Data Processing Addendum on the <u>Fresh Relevance Legal Documents page</u> signed and returned to us.
- 7. If you are doing marketing that requires consent, your data subjects must have given valid consent.
